_____ I will follow all regulations of Recreation and UC San Diego as stipulated in the Sports Clubs Handbook and Coaches' Manual.

_____ I will serve as a liaison between the team, the Sports Clubs Director, Recreation, the Athletic Training team, the University, and the general public. This includes being an OFFICIAL University representative at all home and away contests and being responsible for the team's actions.

_____ I will make every effort to attend practices, home events, and travel with the team to all away competitions.

_____ I accept that student's academic responsibilities supersede all athletic responsibilities. (College Degree 1st, Athletics 2nd)

_____ I will ensure all injuries are reported to the Athletic Trainers in a timely manner.

_____ I understand that my actions, positive or negative, are representative of UC San Diego, Recreation, and the Sports Clubs program. I will practice good sportsmanship at all practices, scrimmages, games (win or lose), etc. I will conduct myself to maintain the highest principles, integrity, and dignity of UC San Diego, Sports Clubs, and my sport in general. I will expect the same of my team on and off the field.

_____ I understand that my position requires leadership skills that must encourage full participation in meeting the goals of the team and its members. I am responsible for the actions of my team as well as my own actions and must be especially aware of what is going on at all times when traveling.

_____ I understand that all practices and games are considered DRY EVENTS; the presence and consumption of alcohol or illegal substances is strictly prohibited. I will neither use nor support the use of illegal drugs; I will neither abuse nor support the abuse of alcohol.

_____ I will not physically, mentally, or psychologically haze or allow any members of my team to be hazed as I respect the dignity of all persons. I understand that hazing is against University and program policies as well as illegal and at the very least will result in immediate termination.

_____ I will make sure to abide by conference rules as far as eligibility. No coach will ever allow a non UCSD-affiliated athlete to play on their team.

_____ I will do all in my power to see that practice, scrimmage, and game sites are safe and will be clean after use, both of trash and equipment, and thus maintained for future events.

_____ I will inform team members and opposing teams of 'field closures' in a timely manner and take appropriate action to cancel scheduled activities. I will report schedule changes to the Sports Clubs Office immediately if our Team Leadership cannot.

_____ I shall never interfere with the duties and jurisdiction of other departments of an institution, including but not limited to admissions, compliance, and the various academic disciplines.

_____ I will never place the value of a win above the objective of instilling the highest ideals and character traits in my players. The safety and welfare of the players will always be the utmost importance and will never be sacrificed for personal prestige or gain.

_____ I am responsible for myself and my team knowing, understanding, and following all rules of the game as established and directed by the conference in which my team participates.

_____ I will complete all necessary online trainings within the deadlines given by the Recreation department. I understand that failure to do so, may result in separation from the team and program until they are completed.

I will uphold said expectations at all times during my enrollment/employment as a coach of a UCSD Sports Clubs team. Adherence of coaches to a code of ethics is largely a voluntary matter. However, if a coach does not follow this code by engaging in gross misconduct, their relationship with UCSD Sports Clubs may be terminated.
