**Provided by Outback Adventures:** Challenge Course facilitators, all necessary equipment, training for use of the course, water, and restroom facilities. Other options, such as meals and accommodations may be arranged separately.

**Provided by client:** Transportation to and from site, parking fees and food for meals and snacks.

**Remit Payment to:** **UC Regents**

**Cancellation Policy:** Outback Adventures reserves the right to cancel this contracted program without cause before the program agreement form and deposit have been received by Outback Adventures. Outback Adventures may cancel a program *less than 21 calendar days* prior to the start of the program only in circumstances which would prohibit safe or feasible execution of the program or cause unreasonable expense for Outback Adventures. In case of cancellation by Outback Adventures, Client will receive a full refund of all fees (including deposits) paid to Outback Adventures within 6 weeks of cancellation date. Outback Adventures assumes no liability for expenses incurred by client outside of fees paid to Outback Adventures.

For cancellation made by the Client *more than 21 calendar days* prior to the program date, Outback Adventures will not refund the registration deposit paid by the client, but will refund any fees paid in

excess of this amount. For cancellations made *less than or equal to 21 calendar days* before the program date, Outback Adventures will retain the entire cost of the program.

**Rescheduling Policy**

If the Client chooses to reschedule a program *less than or equal to 21 calendar days* before the program date, Outback Adventures will retain a minimum of 25% of the program fee or a sufficient amount to cover staffing and operating costs, whichever is greater. The balance of the program fee will be applied to a future program

**Inclement Weather Policy:**

The UCSD Challenge Course is operational in most weather conditions, rain or shine. If Outback Adventures chooses to postpone a program due to predicted or prevailing unsafe weather, the Client may choose to reschedule or receive a full refund of all fees paid.

If due to weather conditions, the Client chooses to reschedule when Outback Adventures deems weather conditions permit use of the UCSD Challenge Course, Outback Adventures will retain a minimum of 25% of the program fee or a sufficient amount to cover staffing and operating costs, whichever is greater. The balance of the program fee will be applied to a future program

**Insurance:**

The University of California, San Diego does not provide individual accident insurance for Client or individual participants on programs. Clients must provide proof of insurance and have the UC Regents listed as additionally insured for the date(s) of the program per specifications. Comprehensive liability insurance is maintained by the University of California, San Diego for aspects of the program under direct leadership of a representative of University of California, San Diego.

**Participant Requirements:**

Prior to participation, each participant must read and complete the Waiver of Liability, Assumption of Risk, and Indemnity Agreement AND the Medical Questionnaire. Closed toed shoes are required for participation.
